Our work with BIS has initiated two successful projects projecting India to the International arena – these include the Medical Graphics project as well as Introduction of AYUSH principles

Message from the Chairperson

Healthcare facilities in India are skewed towards the urban areas and provision of these in the remote areas is patchy at best. Improvements in this scenario are severely impeded by poor infrastructure, transportation and communication facilities in interior regions. Trained doctors are unwilling to move to such areas given their deprived state. So far most projects on telemedicine have concentrated on the technology while the actual need is in implementation and cost effective use of the technology – something which is S.A.T.H.I.'s main focus

Implementation requires reuse of resources and talent available within the local community which will help them earn, and also think of healthcare support as an important remunerative activity. Not only with the community benefit directly but also availability of local resources in the form of trained personnel means urgent help is also possible in times of need.

I am also glad to understand that Lymphodema with 40 million patients in India and between 100 – 300 million world wide has been made a principle and core area of disease management by S.A.T.H.I. I helped S.A.T.H.I. organize World Lymphedema Day on March 6th at Dharamshila Hospital and became acutely aware of how such patients can be helped by S.A.T.H.I.'s approach of using telemedicine support to bring improvement and succor to their quality of life is truly worth emulating.


